## **IN OFFICE NON-IV SEDATION INSTRUCTIONS**

(THIS IS **NOT A FASTING** PROCEDURE SO PLEASE EAT AND DRINK FLUIDS)

#### **BEFORE YOUR PROCEDURE:**

#### YOU SHOULD:

- EAT A LIGHT MEAL 3 HOURS PRIOR TO YOUR PROCEDURE.
- DRINK FLUIDS UP UNTIL PROCEDURE
- SPRAY WITH AFRIN 1 HOUR PRIOR TO PROCEDURE AT HOME
- DO A NASAL RINSE/IRRIGATION AT HOME PRIOR TO YOUR PROCEDURE
- ARRANGE FOR TRANSPORTATION HOME FROM YOUR PROCEDURE. YOU WILL NOT BE PERMITTED TO LEAVE THE OFFICE UNACCOMPANIED AFTER RECEIVING CERTAIN MEDICATIONS
- ARRIVE AT THE OFFICE ABOUT 30 MINUTES BEFORE YOUR SCHEDULED PROCEDURE TO FILL OUT PREOPERATIVE PAPERWORK.
- BRING IN PRESCRIBED MEDICATIONS WITH YOU ON THE DAY OF YOUR PROCEDURE. PAIN MEDICATION/ANXIETY MEDICATION/NAUSEA (ZOFRAN) MEDICATION (THIS WILL BE PRESCRIBED PRIOR TO PROCEDURE)
- START PRESCRIBED ANXIETY/PAIN MEDICATIONS AFTER SIGNING CONSENT FORM IN OFFICE.
- NOTIFY THE PROVIDER DURING YOUR PROCEDURE OF ANY RECENT CHANGES TO YOUR HEALTH. (EXAMPLES OF CHANGES WOULD BE: A COLD, COUGH, SORE THROAT, FEVER, VOMITING, DIARRHEA. ETC)

# YOUR PROCEDURE WILL BE CANCELLED AND RESCHEDULED IF THE ABOVE INSTRUCTIONS ARE NOT FOLLOWED.

### **FOLLOWING YOUR PROCEDURE:**

- MOVE ABOUT SLOWLY AND CAUTIOUSLY FOR AT LEAST 2 HOURS FOLLOWING YOUR PROCEDURE.
- TO AVOID UPSETTING YOUR STOMACH, IT IS RECOMMENDED THAT YOU TAKE WITH FOOD ANY ORAL PAIN MEDICATIONS THAT MAY BE ORDERED BY YOUR PROVIDER
- PLAN TO REST AT HOME FOR THE REMAINDER OF THE DAY, AVOID DRIVING A MOTOR VEHICLE, OPERATING MACHINERY, ETC. MAKE SURE YOU SLEEP ELEVATED TONIGHT IN CASE OF POSTNASAL DRAINAGE.
